Contract entered into by and between:
FARNHAM RIDING SCHOOL
(hereinafter represented by
Tamar Gliksman
Duly authorised thereto)
(hereinafter referred to as "THE STABLE")
And

(hereinafter referred to as "THE OWNER"

Whereas the STABLE conducts business as a livery stable;

and whereas the OWNER wishes to stable his/her horse at the stable;

and whereas the parties wish to reduce to writing the terms of their agreement;

NOW THEREFORE IT IS AGREED AS FOLLOWS: -

Definitions

"THE STABLE" shall mean FARNHAM RIDING SCHOOL situated at Plot 228, Cnr Galanthus and Maple road, Kyalami.

"STABLING" means the stabling, feeding and general day to day care of the horse.

"THE HORSE" shall be the horse nominated and described by the OWNER on the schedule hereto.

STABLING

With effect from the day set forth in the schedule hereto, the Stable shall keep the horse on behalf of the OWNER upon the under mentioned terms and conditions.

1. Payment

- 1.1 The livery fees shall be payable monthly in advance by not later than the 5th of each month. The amount of the livery shall be the sum agreed to by both parties and may be adjusted accordingly where deemed necessary by the Stable.
- 1.2 For any outstanding fees that are not paid by the 10th of the month will entitle the stable to attach any relevant tack of said owner and access or delivery to the owner of the horse or any horses or goods belonging to the owner will be denied until payment of all amounts owing to the stable for the horse or any other indebtedness is made in full.
- 1.3 If the livery is not paid promptly on the due date, then the Stable shall be entitled to cancel this agreement without prior notice and thereafter be entitled to claim immediate payment for any arrears up to date of cancellation together with damages per day thereafter, (at the current monthly rate) for each additional day that the horse is kept by the stable until the horse leaves the stable.
- 1.4 After cancellation of the agreement, the Stable shall have the option to either:-
- 1.4.1 Retain the horse or any other horses or goods belonging to the owner and/or its tack in their possession and exercise a lien thereon until payment is made in full; Or alternatively;

to dispose of the horse immediately upon the instructions of the OWNER or if no such instructions are given, to dispose of the horse by delivering same to an animal welfare organisation such as the S.P.C.A. or A.I.D. (Animals in Distress) without prejudice to its rights to claim the outstanding amount owing to it by the OWNER.

2. Indemnity

- 2.1 The OWNER hereby indemnifies and holds the Stable harmless against any claim of whatsoever nature which may be made against Stable and OWNER arising out of or as a consequence of any damage or loss which may be caused by or suffered by the horse as a result of the Stable STABLING such horse.
- 2.2 This indemnity shall apply in all cases where the horse, acting out of inner excitement or vice (CONTRANATURA) causes loss or damage either to itself or to other persons or property.
- 2.3 The Stable is not responsible for loss, damage or theft of any tack or property belonging to the OWNER, arising out of any cause whatsoever.
- 2.4 The risk in the horse and the tack or property of the OWNER shall remain with the OWNER.
- 2.5 The stable shall not be responsible for any loss, damage or injury to any rider or any horse whilst the horse is being ridden on the stable ground.

3. Exclusions

- 3.1 The Stable shall be responsible only for the livery of the horse and specifically excludes shoeing, veterinary work and schooling.
- 3.2 It shall be the OWNER's responsibility to ensure that the horse is properly shoed, cared for by veterinarian when necessary and schooled, all at the expense of the OWNER.
- 3.3 In cases of emergency when the health or life of the horse is at risk, the OWNER hereby authorises the Stable to employ the services of a veterinarian and undertakes to pay such expenses as will rectify the situation.

4. Inoculations

4.1 The OWNER shall be liable to pay for and to ensure that the horse is properly inoculated or vaccinated against AFRICAN HORSE SICKNESS (compulsory), TETANUS (compulsory) and EQUINE INFLUENZA (compulsory).

5. Notices

- 5.1 The OWNER and/or Stable may terminate this contract at any time provided one calendar months' notice is given in writing and received by the 25th of the preceding month.
- 5.2 The OWNER choose as their domicilia citandi et executandi the address referred to in the Schedule. All notices shall be deemed to be received by the addressee on the third business day after opting thereof, or forthwith upon telefax notice. The OWNER may change their domicilia to another address in the Republic of South Africa of which they may advise to Stable by written notice within 21 (twenty one) days thereof.

6. Recovery of costs

- 6.1 The Stable shall be entitled to recover all legal costs incurred by it, including Attorney/Client charges, tracing fees and such collection commission as the Stable is obliged to pay to its attorneys, from the OWNER.
- 6.2 Jurisdiction of Magistrate's Court
- 6.2.1 At the option of the Stable any action or application arising out of the Agreement or any cancellation thereof may be brought in the Magistrate's Court having jurisdiction in respect of the OWNER.
- 7. The parties hereto acknowledge that this Agreement constitutes the entire Agreement between them and no other conditions, stipulations, warranties or representations whatsoever have been made by either party other than such that may be included herein or subsequently recorded in writing signed by or on behalf of the parties.
- 8. No agreement to cancel, alter or add to this Agreement shall be of any force or effect unless such Agreement is in writing and signed by the parties.
- 9. No variation or consensual cancellation of this agreement shall be of any force or effect unless reduced to writing and signed by the parties.

- 1. This livery fee is exclusive of any veterinary costs, transport fees, show entries, outside service providers, vaccinations, and optional extras.
- 2. Optional extras will be added to your invoice each month.
- 3. Farnham reserves the right to supply your horses with any necessities (as outlined below) should they not be provided by the owner.
- 4. Should you require necessities for your horse, Farnham has reliable suppliers and is able to source and acquire anything you might need at your cost.
- 5. Lessons are not included in your livery fee. Please ask for a lesson form for lesson fees.
- 6. *Cylence is an effective treatment against midges and helps protect your horse against African Horse Sickness.
- 7. Please refer to your Year Planner attached below for monthly extras so as to budget accordingly.

SECTION 7: LIVERY STARTER KIT

In order to help you keep costs down, we ask you to keep the following equipment outside your horses stable in a secure box. This ensures that your horse is always receiving the best possible care at no extra charge to you.

All of this equipment is vital to your horse's well-being. If prefer to bring your own stock, please ensure your boxes are stocked at all times to avoid unnecessary charges to your account. For your convenience, we will stock your boxes for you and charge to your account if you require.

Please make sure ALL your stock and equipment are clearly labelled to avoid things going missing or being used on the wrong horse.

Halter & Lead Rein	For leading to and from the paddocks and for use at shows.
Fully stocked grooming kit *if you are unsure as to what items are needed, please speak to our yard manager for a comprehensive list.	To ensure that your horse is kept clean all the times. Each horse must have their own as sharing of brushes can lead to skin problems.
Polo wraps/ Bandage pads	We offer a tack up service free of charge as well as lunging or exercising.
Tendon boots / Brushing boots	Having this equipment in your stable-box ensures that your horse always has the right equipment on hand.
Velcro overreach boots	the right equipment of hand.
Sweat sheet & day sheet	After exercise maintenance, if your horse is caught in a Highveld downpour or the weather turns chilly.
Stable bandages and pads	Help reduce heat and swelling after hard exercise. (only necessary if used with leg brace)
Leg brace	A home-made solution to help reduce heat and inflammation in horses' legs after work. We can supply you with this or give you the recipe to make your own.
Fly mask	Keeps flies out of your horses' eyes
Fly spray	Grooms spray the horses 3x a day. You should also spray your horse before and after every ride. The yard can supply your flyspray for you, or you can bring you own. (approx. 21 are used per month per horse)
Tabard lotion	Used only in summer months for horse sickness prevention, we add Tabard is applied directly to the horses' body twice a day. We can supply this in bulk for you, or you can organize your own. (approx. 2 x 150ml bottles are used per month per horse)

Purple spray	Any nicks and cuts can be treated without charge. (1 x tin)	
Wound ointment (Dermavet)	To soften scabs and disinfects slightly more serious cuts. (1 x tube)	
Sunblock (Only for horses with pink noses)	For summer only to prevent sunburn for horses with pink noses.	
Shampoo	Show prepping and plaiting is provided at no extra cost, however we do cha for shampoo and elastics. We can provide this for you, or you can bring you	
Elastics	own (1 x 1litre per horse per month). Please provide elastics to match the colour of your horse.
